President's Comments

The President opened the meeting with some short comments on the state of Squash in the National Capital Region. General sense is that it's in good shape. The President noted that over the summer the ODSA has procured independent insurance coverage for coordinators of all ODSA related events. Coverage is superior to previous insurance provided by SQ ONT and will cover anyone involved in organizational efforts for all ODSA activities. This includes (but is not limited to) ODSA board members activity, ODSA Cup organization, City league organization, Women's League organization, and the organization of ODSA Junior activities and tournaments.

Treasurer's Report

The Treasurer provided an overview of the state of the ODSA account. He reported that the ODSA continues to be in sound financial health, with a standard of 6 months operating costs available if needed. Treasurer did note that the advertising aspect of our website has yet to yield much income and could be an area worth exploring.

PORTFOLIO REPORTS

Open City League

The following comments and discussion were made WRT Open City League for the upcoming season:

- Team declarations have be called for submission due date; end September.
- ODSA will continue to use PAR 15 for City league. (except for Div.1)
- There was potential for a Division 7 again this year. Manually run by Mikola.
- Running of The Open CL would remain a two man effort. Mikola Czich would remain the lead coordinator and Brian Eldridge would continue his roll as the ODSA Open City League Scheduler.
- 36 teams continues to be the magic number.
- 1 up 1 down system to continue. First session included.
- \$150 per team league fee
- Start date; October 16th

Women's City League

Lesley Kelly reported that the Women's League will be using a Box System, 25-30 players expected to participate. 5 week sessions. Majority of players are from the RA. Courts are available on Thursday evenings at various clubs.

ODSA CUP

Denis Theriault offered to run the ODSA Cup again for the upcoming season. He was thanked by the board for his last year's efforts. He expects to run the tournament from January-April. Some comments included:

- Payment was an not a major issue.
- Sporthèque to offer a payment option via their website.
- Hoping to secure 70 people for the draw.
- \$10 per player continues to be the tourney fee.
- Juniors were not well-represented in past but they are welcome
- "A" players the toughest to recruit and play matches in a timely manner.

Juniors

Junior representative not available; Mikola mentioned that;

- Program continues to be fairly successful
- 4 players attended the CDN Open in BC.
- Calvin Wren finishing a very respectable 2nd in his age category.
- Junior Gold to be held at OAC/18-20th of October. Steve Wren and Ian Woodhead working hard to ensure that the event is a success.

ODSA Website

The ODSA real-time online ranking system, developed by Brian Eldridge, is running smoothly. Juniors are also included in real-time updates (ages not visible). Filters provide easy access to pertinent information. Nicolas Grenapin will continue on as webmaster. It was agreed that advertising on the site for 1 year would cost \$100.

Officiating:

Norman Brie has offered to be the Officiating rep. There will be an attempt to slot in an officiating clinic before the start of the 2013 city league season. It was noted that the higher levels within city league prefer not to have referees while the lower levels are more consistently using referees.
